

HOW CAN I FULFILL MY INTENT TO GIVE \$1,000?

The path to fulfilling your Paul Harris Society giving intentions each year is up to you. You can donate \$1,000 at one time or in several smaller amounts that reach that total and eligible UK tax payers can also select the option to Gift Aid their donation(s). One easy way is to set up recurring/regular giving via Direct Debit (see information overleaf). For example you can choose to donate a set amount per.

- Month (GBP amount equivalent to \$85)
- Quarterly (GBP amount equivalent of \$250)
- Annually (GBP amount equivalent of \$1,000)
